# 1. Member Reports

S.Paton reported that the spadefoot toad project is moving forward. A.Fox 's father has agreed to provide an excavator and operator but needs more information on the project. Dates set to perform project are May 14-16, 2019. There was a discussion of reaching out to the Friends of the Land Trust for volunteer help during the pool construction period.

S. Paton reported that Shaun McBurney noticed two cars had been broken into New Year's Eve/Day at the Crawley Preserve. He picked up the mess from the auto glass. S.Paton will notify SK Police of the incident.

### 2. Land Trust Brochure Discussion

A.Fox says work is continuing on the brochure and will have a more robust draft to show at the February meeting. There was a discussion of delaying brochure printing to obtain photos of the preserves in late Spring.

### 3. Stewardship Committee Discussion

Continued the ongoing discussion of forming a stewardship committee. Tasks such as trailblazing, parking lot creation at the Salia Preserve, general trail maintenance, and preserve stewardship were

discussed. Need to establish a network of volunteers. D. Poyer suggested the idea of "stewardship days". S.Paton shared the USFWS' group, "The Tuesday Club", a group of volunteer carpenters, and how they build items that the various USFWS properties need. D. Poyer suggested we create a clear structure and plan for the stewardship committee, then reach out to prospective stewards and volunteers. Next steps: come up with a structure for the stewardship committee.

S.Paton brought up board vacancy and shared some names that might be a good fit. She will reach out to these individuals to gauge their interest.

R. Anderson stated we need to have the election of officers for 2019. This will be on the agenda for the February meeting.
