PRESS RELEASE - April 30, 2013:

1. **Misdemeanor - Motor Vehicle:** On April 23, 2013 at approximately 7:07 PM, Patrolman Steven Gravier arrested **Todd Keister**, age 41, of 33 Rocky Acres Drive, Charlestown on a charge of *Operating with a Suspended License*, after a motor vehicle stop on Main Street at Route 95 revealed that his license had been suspended in September 2012. Mr. Keister was subsequently released with a summons to appear on May 16th, 2013, for arraignment in 4th District Court on the above charge.
2. **FELONY - Larceny of a Firearm:** On April 23, 2013, at approximately 9:53 PM, Patrolman John Randall arrested **Randy Myers**, age 18, of 10 Summit Road, Richmond on a felony charge of *Larceny of a Firearm (Glock 9 millimeter pistol)* after an investigation into a complaint by a family member at the above address, which was initially investigated by Patrolman Randall with follow-up investigation by Patrolman Jeff Vaughn. Mr. Myers was processed at the station and was held overnight. He was arraigned in 4th District Court on the above charge, and was released on \$5,000 personal recognizance.
3. **Misdemeanor - Motor Vehicle:** On April 25, 2013 at approximately 9:37 PM, Corporal William Litterio arrested **Nicholas J. Pepler**, age 28, of 8 Ledoux Drive, Hope Valley on a charge of *Operating with a Suspended License*, after a motor vehicle stop on Route 95 Northbound (from Kingstown Road) revealed that his license had been suspended in December 2012 for *Failure to Appear/Pay*. Mr. Pepler was transported to the station where he was processed, and was released with a summons to appear for arraignment in 4th District Court on May 30th, 2013, on the above charge.

4. **Bench Warrant:** On April 26th, 2013 at approximately 11:16 AM, Corporal Litterio arrested **Raymond S. Robar**, age 32, of 160 Old Shannock Road, Charlestown on the strength an outstanding **4th District Court Bench Warrant** that had been issued on April 24, 2013, for *Failure to Appear* on original charges of (1) *Possession of a Controlled Substance (Cocaine)*, (2) *Possession of a Controlled Substance (Heroin)*, and (3) *Operating on a Suspended License* (Richmond Police Department), after a motor vehicle stop on South County Trail. The underlying charges stemmed from a motor vehicle stop conducted by Corporal Litterio back on March 28th, 2013. Mr. Robar was processed at the station before being transported to 4th District Court, where he was arraigned on the above charges.
5. **Misdemeanor - Driving While Impaired:** On April 28th, 2013, at approximately 1:38 AM, Corporal William Litterio, assisted by Patrolman Daniel Kelley, arrested **Cody J. Moorehead**, age 19, of 124 Switch Road, Richmond on a charge of *Driving While Impaired*. Corporal Litterio had stopped Mr. Moorehead's vehicle on Switch Road for speeding (62-MPH in a posted 30-MPH-zone), and subsequently discovered that the vehicle contained three other (3) teenage passengers. Mr. Moorehead, who was under the legal drinking age, submitted to a Breathalyzer test that resulted in BAC (blood-alcohol-content) readings of **.086 (1st phase)** and **.083 (2nd phase)**. Mr. Moorehead was processed and released with a summons to appear for arraignment on May 23rd, 2013, in 4th District Court on the above charge.
6. **Bench Warrant:** On April 30th, 2013 at approximately 2:50 PM, Patrolman Adam Andrukiewicz arrested **Jennifer E. Hilton**, age 37, of 115 Biscuit City Road, Charlestown on the strength an outstanding **4th District Court Bench Warrant** that had been issued on November 15, 2012, for *Failure to Appear - Cost Review* on an original charge of *Possession of a Controlled Substance* (RI State Police - Wickford Barracks). Patrolman Andrukiewicz had been dispatched to investigate a minor car accident involving Ms. Hilton at the McDonald's Restaurant in Wyoming, which revealed the aforementioned bench warrant. Ms. Hilton was processed at the station and subsequently arraigned by a Justice-of-the-Peace.
