#### Who must obtain this license

Anyone who sponsors or promotes a public entertainment event or show, including a performance, an exhibition, or a dance, must have an entertainment license. The license is required to protect the health and safety of the public.

### Application deadline

The Town Council must approve the license. The license application must be submitted to the Town Clerk at least 30 days before the date of the Town Council meeting.

#### Requirement for holding a license

The Richmond Police Chief has the authority to assign police officers or constables to the location to control the number of people in a room. If the Chief decides that crowd control is needed, the license holder must pay for the police coverage.
