A. CALL TO ORDER

The meeting was called to order at 3:00 P.M.

B. NEW BUSINESS

Please Note in Accordance with Section 42-46-6 (b) the Commission May Review, Discuss and/or take Action on the following items:

- 1) Canvass and Correct the Voter List for the Chariho All Day Referendum II

The Board of Canvassers reviewed and approved the list of voters eligible for the Chariho All Day Referendum.

- 2) Review the Poll workers for the Chariho All Day Referendum II (Date-TBD)
