PRESS RELEASE – September 17th, 2013:

- 1. Misdemeanor – Disorderly Conduct:** On Monday, September 9th, 2013, at approximately 5:52 PM, Corporal William Litterio arrested **Daniel Lister**, age 44, of 79 Small Pox Trail, Richmond on a charge of **Disorderly Conduct** after an employee of the Meadowbrook Golf Course called to report that a highly intoxicated male subject had just left their business and was walking westbound along Route 138. Corporal Litterio subsequently observed Mr. Lister walking in the westbound lane, impeding with oncoming traffic. When he stopped to check on Mr. Lister's well-being, the subject became belligerent, profane, and confrontational. Mr. Lister was processed at the station, and was later released to a family member with a summons to appear on 9/26/13 for arraignment in 4th District Court.
- 2. Misdemeanor – Simple Assault, Disorderly, and Resisting Arrest:** On September 11, 2013, at approximately 7:23 PM, Patrolmen Adam Andrukiewicz arrested **Christina R. Paliotti**, age 22, of 7 Dawn Lane, Richmond, on charges of (1) **Simple Assault**, (2) **Disorderly Conduct**, and (3) **Resisting Arrest**, after being dispatched to the Stop & Shop in Wyoming relative to an altercation between two (2) women in front of the store. Investigation revealed that a female store employee had confronted Ms. Paliotti about allegedly shoplifting a sweatshirt from the store, at which point Ms. Paliotti reportedly attacked the employee. The sweatshirt was subsequently returned to the store, and Ms. Paliotti was transported to the station where she was processed and later released with a summons to appear on 10/10/13 for arraignment in 4th District Court on the above charges.

3. **Misdemeanor - Motor Vehicle:** On September 12, 2013, at approximately 6:08 PM, Patrolman Jeff Vaughn arrested **Curt E. Palmer**, age 45, of 965 Main Street, Hopkinton, on a charge of **Operating with a Suspended License**, after a motor vehicle stop on Switch Road. Mr. Palmer was transported to the station, where he was processed and released with a summons to appear on 9/26/13 for arraignment in 4th District Court on the above charges.

4. **Misdemeanor -Domestic Disorderly Conduct:** On September 14, 2013, at approximately 5:02 PM, Patrolmen Daniel Kelley and Adam Andrukiewicz arrested **Frederick H. Johnson**, age 65, of 23 Wendy Lane, Richmond, on charges of **Domestic -Disorderly Conduct**, after officers were dispatched to that address for a "911-hang-up call." Officers arrived to investigate a domestic dispute, which led to the arrest of Mr. Johnson, who was processed at the station. He was later arraigned before Justice-of-the-Peace Joseph Scott, and was released on \$1,000 personal recognizance, along with a *No-Contact Order* barring him from contact with the alleged victim.
