## PRESS RELEASE – July 9<sup>th</sup>, 2013:

1. **Bench Warrant - Failure To Appear :** On July 2<sup>nd</sup>, 2013, at approximately 11:30 PM, Corporal William Litterio arrested **Kimberly M. Lear**, age 42, of 8 Beta Court, North Providence on the strength of a *District Court Bench Warrant*. Ms. Lear was arrested after the report of a suspicious person outside a Main Street business. Ms. Lear was processed at the station and transported to the ACI Women's Intake Center where she was held without bail.
2. **Bench Warrant-Failure To Appear:** On July 3<sup>rd</sup>, 2013 at approximately 10:17 PM, Patrolmen Daniel Kelley and Jeffrey Vaughn arrested **Shannon N. Godbout**, age 29, of 56 Highview Avenue, Hopkinton, on the strength of a *District Court Bench Warrant* after officers were dispatched to gas station on Main street for a report of a disturbance. Ms. Godbout was returned to the station for processing, and appeared before Justice of The Peace James Callaghan who released Ms. Godbout on bail.
3. **Misdemeanor – Simple Assault and Disorderly Conduct:** On July 5, 2013 Corporal William Litterio arrested **Ryan Bongiovanni**, age 20, of 24 Inkberry Drive, South Kingstown on charges of *Simple Assault* and *Disorderly Conduct*, on the strength of an Affidavit and Arrest Warrant after an investigation into a citizen complaint that Mr. Bongiovanni had threatened a male complainant at his residence. The complainant stated that Mr. Bongiovanni was holding mace and a machete at the time of the incident which stemmed over a disagreement regarding damage to a vehicle. Mr. Bongiovanni turned himself in at the Richmond Police Station where he was processed and then arraigned by Justice of The Peace Joseph Scott. Mr. Bongiovanni was released on Personal Recognizance with a promise to appear in 4<sup>th</sup> District Court on July 18<sup>th</sup>, for Re-arraignment on the charges.
4. **Misdemeanor – Motor Vehicle:** On July 6<sup>th</sup>, 2013 at approximately 4:41 PM, Corporal William Litterio arrested **Amanda L. Gadway**, age 21, of 28 Summer Street, Norwich, CT, on a charge of *Operating with a Suspended License*, after a motor vehicle stop in Richmond revealed her CT license was suspended. Ms. Gadway was transported to the station, processed and released with a summons to appear for arraignment in District Court on the above charge.

5. Misdemeanor - Motor Vehicle: On July 7<sup>th</sup>, 2013 at approximately 3:45 PM, Corporal William Litterio arrested **Roy Spiridi**, age 31, of 60 Peveril Road, Cranston, on a charge of *Operating with a Suspended License*, after a motor vehicle stop in Richmond revealed that his license had been suspended. Mr. Spiridi was transported to the station, processed, and released with a summons to appear for arraignment in District Court on the above charge.

Misdemeanor - Motor Vehicle: On July 8<sup>th</sup>, 2013 at approximately 6:38 PM, Corporal William Litterio arrested **Jean Trombley**, age 63, of 1 Arbeth Avenue, South Kingstown on a charge of *Operating with a Suspended License*, after a motor vehicle stop on Switch Road revealed that her license had been suspended. Ms. Trombley was transported to the station, processed and released with a summons to appear for arraignment in District Court on the above charge.
