PRESS RELEASE - October 8th, 2013:

- Misdemeanor DUI (BAC Unknown) & Refusal: On October 1st, 2013, at approximately 3:50 PM, Patrolman Dan Kelley, assisted by Patrolman Adam Andrukiewicz, arrested Aimee G. Lillibridge, age 36 of 50 Tanglewood Lane, Voluntown, CT on charges of (1) Driving Under the Influence of Alcohol and/ or Drugs (1st Offense BAC unknown), and (2) Refusal to Submit to a Chemical Test, after a motor vehicle stop on Main Street. Mrs. Lillibridge was transported to the station where she was processed, and subsequently arraigned by Justice-of-the-Peace Joseph Scott. She was released on \$1,000 personal recognizance, pending future appearances in 4th District Court and the RI Traffic Tribunal on the above charges (respectively).
- 2. WAYWARD JUVENILE DISORDERLY CONDUCT: On October 1st, 2013, at 8:30 PM, Patrolman Adam Andrukiewicz arrested a 14-year-old male subject on a charge of Wayward/Delinquent as a result of being dispatched to the *Corkery House for Boys*, at 15 Baker Pines Road, after the youth had eloped from the facility on a 3rd consecutive occasion, despite being court-ordered to attend the program. Due to his refusal to return to the facility, the youth was delivered to the Rhode Island Training School in Cranston, per the order of an after-hours Family Court judge. He shall be petitioned into Family Court on the above charge.
- 3. Misdemeanor DUI (BAC Unknown) & Refusal: On October 2nd, 2013, at approximately 12:30 AM, Patrolman Dan Kelley arrested Alex F. Minteer, age 25 of 243 Richmond Townhouse Road, Richmond, on charges of (1) Driving Under the Influence of Alcohol and/ or Drugs (1st Offense BAC unknown), and (2) Refusal to Submit to a Chemical Test, after a motor vehicle stop on Kingstown Road. Mr. Minteer was transported to the station where he was processed, and subsequently released with a summons to appear for arraignment in 4th District Court on 10/17/13, along with a citation to appear at the RI Traffic Tribunal on the above Refusal charge.
- 4. Misdemeanor Motor Vehicle: On October 3rd, 2013, at approximately 11:00 AM, Patrolman Adam Andrukiewicz arrested Lauren M. Silvia, age 27, of 534 Switch Road, Richmond, on a charge of Operating with a Suspended License, after a motor vehicle stop on Switch Road during a Seat Belt Enforcement Detail revealed that her RI operator's license had been suspended. Ms. Silvia was transported to the station, where she was processed and was released with a summons to appear on 10/31/13 for arraignment in 4th District Court on the above charge.

- 5. FUGITIVE FROM JUSTICE / STOLEN GOODS: On October 3, 2013, at 11:15 AM, Corporal William Litterio arrested Christopher E. Schreffler, age 46, of 224 Unit Street, Providence, on multiple charges and outstanding bench warrants after stopping his unregistered vehicle on Buttonwood Road. Corporal Litterio subsequently learned that Mr. Schreffler was driving on a suspended driver's license, and was wanted on two (2) outstanding 6th District Court Bench Warrants stemming from Failure to Appear on charges of Operating on a Suspended License and Shoplifting (East Providence Police). Additionally, there was an outstanding arrest warrant held by the Seekonk Police Department in Massachusetts charging him with *Larceny*. During the motor vehicle stop, Corporal Litterio located and seized a brand new 8,000-watt GENERAC generator, valued at over \$1,000, in the back seat of the unregistered Nissan Maxima. Mr. Schreffler was returned to the station where he was processed. subsequently transported to 4th District Court where he was arraigned on charges of (1) Operating on a Suspended License; (2) Obstructing a Police Officer; and (3) Fugitive from Justice (Seekonk MA). Further investigation later revealed that the above generator had been stolen earlier that same morning from the Lowe's Home Improvement store in Waterford, Connecticut. An additional misdemeanor charge of Receiving Stolen Goods (under \$1,500) shall be brought against Mr. Schreffler on a future date.
- 6. <u>Misdemeanor Motor Vehicle:</u> On October 4th, 2013, at approximately 3:47 AM, Corporal Justin Vachon arrested Kaliegh A. Rogers, age 20, of 70 Foster Sheldon Road, Wakefield, on a charge of Operating with a Suspended License, after a motor vehicle stop on Kingstown Road revealed that her RI operator's license had been suspended. Ms. Rogers was transported to the station, where she was processed and released with a summons to appear on 10/17/13 for arraignment in 4th District Court on the above charge.
- 7. Misdemeanor Motor Vehicle: On October 4th, 2013, at approximately 8:48 PM, Corporal William Litterio arrested **David M. Penta**, age 25, of 4 Tarpon Lane, Apartment 2, Charlestown, on a charge of **Operating with a Suspended License**, after a motor vehicle stop on South County Trail revealed that his RI operator's license had been suspended on 8/20/13. Mr. Penta was transported to the station, where he was processed and released with a summons to appear on 10/24/13 for arraignment in 4th District Court on the above charge.
- 8. Misdemeanor Disorderly Conduct: On October 6th, 2013, at approximately 6:56 PM, Corporal William Litterio and Patrolman Adam Andrukiewicz arrested Leonard R. Ponte, age 72, of 11 Sunset Drive, West Kingston, on a charge of Disorderly Conduct, after the Department received a 911-call reporting that Mr. Ponte had confronted a male neighbor about another family's use of recreational vehicles on the nearby wooded area governed by the neighborhood's homeowners association. The victim declined to file assault charges, but an arrest was made as a result of statements made by an alleged eyewitness. Mr. Pont was transported to the station, where he was processed and later released with a summons to appear on 10/31/13 for arraignment in 4th District Court on the above charge.
